



EQUIPMENT RENTAL AGREEMENT

Agreement made between International Light Technologies (hereafter called Owner) and \_\_\_\_\_ (hereafter called Renter)

The Owner covers two days of transit time only. If the equipment is not returned within two days of the termination date the Renter agrees to pay additional rental rates at the agreed upon daily/weekly rates continuing until the equipment is returned. Extended rental rates are \$60 /day per set or we can extend to the agreed upon weekly rate.

Renter shall during the rental period keep and maintain the rented equipment in good condition and shall be responsible for any loss, casualty, damage or destruction to said equipment. Renter agrees to return said property in its present condition.

In the case of loss, casualty, damage or destruction Renter agrees to pay the full replacement value for said equipment, less the rental price already paid.

## RENTAL TERMS AND CONDITIONS

1. Owner will provide a packing list of all items associated with the equipment and will verify the functionality of the equipment prior to shipping.
2. Renter agrees to inspect and verify the functionality of the equipment upon receipt and will notify Owner of any damages, malfunctions or missing components within 3 days of receipt of equipment so that appropriate measures can be taken. The equipment shall remain the property of the Owner at all times, unless a sales agreement is negotiated for the purchase of the equipment separate from this rental agreement.
3. The Renter is responsible for all freight charges.
4. The rental period shall cover the agreed upon rental period paid up front, plus two additional days for transit. The Renter agrees to return the equipment within two days of the termination date or pay extended rental rates at a daily/weekly rate.
5. The Renter agrees to pay all rental fees prior to rental on a valid and approved credit card. If the equipment has not been received back at the Owner's facility within two days of the termination date the Renter agrees to pay extended rental rates at the agreed upon daily/weekly rates continuing until the equipment is returned. Extended rental rates are \$60 a day per set or we can extend to agreed upon weekly rate. Monthly rates do not qualify for extended rental without prior approval from Owner.
6. Renter shall not remove, alter, disfigure or cover up any numbering, lettering or logo's displayed upon the equipment, and shall see that the equipment is not subjected to careless, unusually or needlessly rough usage.
7. Renter shall during the rental period keep and maintain the rented equipment in good condition and shall be responsible for any loss, casualty, damage or destruction to said equipment. Renter agrees to return said property in its present condition.
8. In the case of loss, casualty, damage or destruction Renter agrees to pay the full replacement value for said equipment, less the rental price already paid.
9. No discount will be given for any rented equipment which is claimed not to have been used.
10. Renter and its employees or agents waive any right to make any claim against Owner for damages or personal injury resulting from misuse of equipment.
